Fair Trade USA was founded in 1998 as a nonprofit committed to setting standards, certification, and product labeling for the promotion of sustainable livelihoods and environmental protection. Fair Trade USA and ZJT have made strides in:

- 1. Reducing poverty
- 2. Decreasing child mortality
- 3. Improving drinking water & sanitation in rural tea villages















Sustainability **Organizations in China**



The Rainforest Alliance is a non-governmental organization founded in 1987 to conserve biodiversity and ensure sustainable livelihoods. In conjunction with the ETP, the Rainforest Alliance supports sustainability in Chinese tea via:

- 1. Increasing farm productivity and climate-smart farming
- 2. Conserving biodiversity, wildlife protection, GMO crop prevention
- 3. Conserving resources, water/soil conservation and management
















Annual reports from Fair Trade USA shows China's contribution to Fair Trade imports to the US have increased from 23% of total imports in 2008 to over half (52%) in 2016. Requested data for 2017-2019 was unavailable at time of writing.


Firsd Tea carries many these Fair Trade certified teas in our regular US inventory. China has risen to contribute over half of all US Fair Trade imports











US imports of **USDA certified organic** teas, as tracked by import (HS) code, shows that China accounts for over half of all organic tea brought into the US. With the exception of one year, this has held true for the past five years. China is a major supplier of organic teas, particularly organic green teas.

Sustainable development begins at the top in China. The country's own sustainability goals are patterned after UN Sustainable Development Goals. These goals include 17 areas of targeted improvement areas. China's own Number 1 Central Document is released every 5 years, and usually prioritizes: poverty alleviation, rural development, agriculture, and food security.

Achieving UN/China Sustainability









The UN and China have set sustainability goals that include eliminating poverty

According to the World Bank:

China's poverty rate dropped from 88% in 1981 to 0.7% in 2015, accounting for more than **75% of total global poverty** reduction during that period.

China's State Council Poverty Alleviation Office lists over 300 counties across multiple provinces in need of significant economic development









Achieving UN/China Sustainability









Both UN and China goals for sustainability include rural and infrastructure development.

Improvements in water, sanitation, transportation infrastructure, pre-processing facilities with related labor, pension, health care, and education, contribute to sustainable industry and communities

Investments in infrastructure – including transport, sanitation, and power grids are crucial to achieving sustainable development and empowering communities.

7JT became **China's first USDA certified** organic tea producer in 1989, and maintains those high standards



Our Sustainable Programs

Many, if not all ZJT farms and facilities have benefited from the work of the ETP. Fair Trade and Rainforest Alliance. Below are a few of the specific locations where successful sustainability initiatives are happening:















Jiulong Mountain Tea Base (Zhejiang Province) is Rainforest certified to produce over 1.2 million kilograms of Rainforest certified tea. Working under Rainforest's guidelines, Jiulong enhanced their sustainable agriculture practices and pesticide management. The programs included proper use of personal protection equipment (PPE), and responsible agrochemical application, storage, and disposal.



Rainforest certified Jiulong Mountain Tea Base produces over 1.2 million Kg of Rainforest certified tea.









Zhejiang Anji Huada Tea Factory



ZJT's Anji Huada Tea Factory is a recognized participant in Ethical Tea **Partnership** programs. These programs focus on the safety and protection of employees, equitable compensation, and environmental protection practices. The Huada facility processes Rainforest and Fair Trade certified Gunpowder and Chunmee green teas.

New Sustainability Projects



In April 2018, Huangdu Village, Zhejiang Province coordinated with ZJT to donate 15 million tea plants to poverty stricken areas.

Recipients included **34 villages** across impoverished areas targeted for development. The donation of tea plants and creation of tea farms aims to further ZJT and China's sustainable tea programs.



Donation of 15 million tea plants













Guzhang County, Hunan Province

1.5 million tea plants have been established in the 660-acre "Baiye No. 1" demonstration garden. Harvesting occurred on March 25, 2020. In the past two years, 116 households and 430 people in 3 poverty-stricken villages have seen sustainable economic gains.

Qingchuan County, Sichuan Province

5.4 million tea plants were set, to raise incomes of 2,064 people from 663 households in 18 villages

Yanhe County, Guizhou Province

3.6 million tea plants established in 3 villages. The first harvest occurred this Spring 2020

Sustainable Development:

- 859 acres of in development
- 34 villages uplifted
- 3,839+ households improved

Pu'an County, Guizhou Province

Encouraged by the success of the first round of planting, the county planted an additional 733 hectares to support more than 2,577 people in 862 impoverished households.

This ambitious sustainability program, stretching across multiple counties and provinces, is lifting 3,839 households out of poverty while protecting the environment.









New Sustainability Projects



Rendering of completed Pu'an Industrial Park



One of the recipient areas of tea plant donations is Pu'an County, Guizhou Province.

The sustainable development program for Pu'an includes an industrial park (processing facility) that began production in Spring 2020. Output is projected to reach 10,000 tons of dry leaf per year, and **134 hectares of tea fields** were completed as of Spring of 2019.

Sustainable Development:

- Creating over 1,000 jobs
- Lifting over 5,839 people out of poverty
- Contributing over 400 million RMB (\$56 mil USD) in economic value
